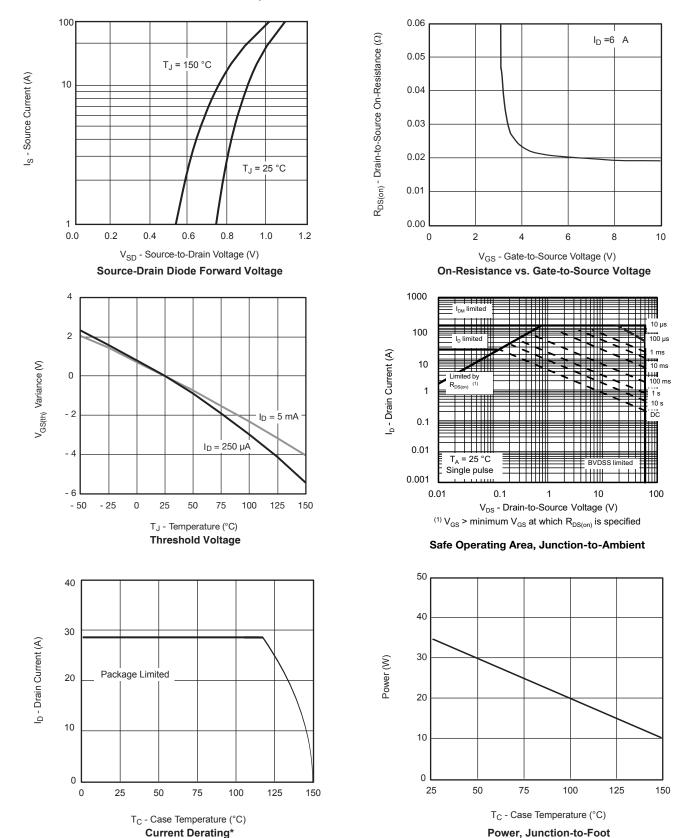


TYPICAL CHARACTERISTICS 25 °C, unless otherwise noted






TYPICAL CHARACTERISTICS 25 °C, unless otherwise noted




DFNWB5×6-8L-B(P1.27T0.75/0.85) PACKAGE OUTLINE DIMENSIONS
