


**On-Resistance vs. Drain Current and Gate Voltage** 








**On-Resistance vs. Junction Temperature** 









**Threshold Voltage** 



On-Resistance vs. Gate-to-Source Voltage




Single Pulse Power






Square Wave Pulse Duration (s) Normalized Thermal Transient Impedance, Junction-to-Foot




