







**On-Resistance vs. Drain Current and Gate Voltage** 







V<sub>GS</sub> - Gate-to-Source Voltage (V) Transfer Characteristics

















On-Resistance vs. Gate-to-Source Voltage








Normalized Thermal Transient Impedance, Junction-to-Foot













