RECOMMENDED MINIMUM PADS FOR DPAK (TO-252)

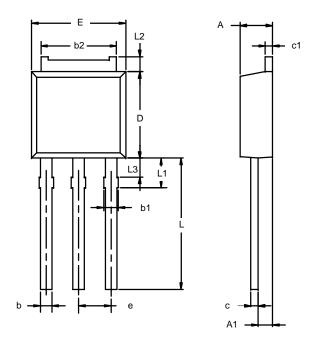


Recommended Minimum Pads Dimensions in Inches/(mm)
